## World Bank Logistics Ranking (LPI)

According to the latest Logistics Performance Index (LPI) Report issued by the World Bank, Oman improved 11 places in comparison with 2014 report with an LPI score of 3.23. Oman is now ranked 48th globally compared to the 59th spot it occupied in 2014. The report pointed out that the jump reflects major improvements in logistics quality, customs, logistics infrastructure and competence. In the Middle East and North Africa region, Oman came fifth, pared to seventh place in the 2015 ranking.





#### The Logistics Strategy Team Welcomes Tapio Naula

Tapio Naula joined us as Programme Director – Trade Facilitation at Oman Global Logistics Group. Before joining us, he worked as a consultant at the World Bank where he co-authored and co-designed the World Bank's Logistics Performance Index.

He has also worked with a number of other international development organizations such as USAID, GIZ, UNIDO and the EU - covering Central Asia, Afghanistan, Macedonia and the Baltic States. He was Deputy Director of USAID, Regional Trade Liberalization and Customs Project covering Kyrgyzstan, Kazakhstan and Tajikistan. He is an expert in international third party logistics and outsourcing of logistics services.

#### **Markets**

The key objective of the Markets Pillar is to position Oman as the first choice logistics hub in the region & make Oman a recognized global logistics brand, particularly in its target markets and segments. To increase market share, the selection of the priority segments and targeted geographies for business anchoring has started with target to complete Phase 1 by year-end.

#### **Human Capital**

The main objective of the Human Capital Pillar is to attract and educate enough young people in logistics that meet the ambitions of the workforce sector's programme. Twenty-one core functions are defined across all logistics sectors covering 291 roles. In addition, there are more than 29 job roles need to be mapped to the logistics functions. In terms of the competence frameworks for performance and training standards, all of these job roles are attached to more than 23 international qulaification organizations.

### Technology

The objective of the Technology Pillar is to ensure safe and quick transport of cargo through the transfer of information or data about the cargo, its condition & location. This is to improve and increase the utilization of transport and logistics technology throughout the supply chain and the economy of Oman. Also, to identify all the technologies used in the logistics sector in Oman to compare it with the ones being used worldwide in order to identify areas of improvements.

### **Trade Facilitation**

The Trade Facilitation objective is to provide transparency, simplification, harmonization and standardization across the process involved in conditioning of cargo movements and new business establishment - in order to enhance the efficiency of the logistics business. This will harness Oman's competitiveness as a logistics hub and attract new investments.

Many programs are currently under execution for the Trade Facilitation, e.g. Authorized Economic Operator

(AEO). Port Community System (PCS), Bonded Warehousing, re-engineering the logistics processes & TIR. A task force with members from government and private sector is actively working to **Trade Facilitation Principles** support the efforts of the Standardization Harmonization ransparency trade facilitation Simplification team.
